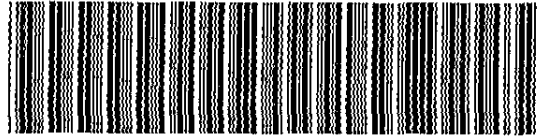

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be: NU TESTAMENT MINISTRIES INC., (hereinafter referred to as the "Ministry").

ARTICLE II. PURPOSE

The purpose and object of the Ministry shall be to teach and spread the gospel of Jesus Christ, in word, song and deeds, to utilize biblically based methodology in music, publishing, broadcasting, research, counseling and professional approaches to healing and ministering to the body, mind, and spirit. The Ministry shall also conduct any and all business consistent with the laws of the State of Florida and United States of America.

ARTICLE III. PRINCIPAL PLACE OF BUSINESS

The principal place of business of this Ministry shall be 2873 West 15th Street, Jacksonville, Florida 32254.

ARTICLE IV. TERM OF EXISTANCE

Commencing on August 18, 2003, the Ministry shall have perpetual existence.

ARTICLE V. MEMBERSHIP

Pursuant to the By-Laws, membership in, and services offered by the Ministry are open to all individuals, on a non discriminating basis.

ARTICLE VI. BOARD OF DIRECTORS

The business affairs of the Ministry shall be managed by the Board of Directors. The Board of Directors shall be elected by the members of the Ministry from among the membership at the annual membership meeting as provided in the By-Laws. The number of members of the first Board of Directors shall be five. The names and addresses of the persons who are to serve as the initial Board of Directors of the Ministry until their successors are chosen are:
