ARTICLES OF INCORPORATION OF NU TESTAMENT MINISTRIES INC. A CORPORATION NOT-FOR-PROFIT

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be: NU TESTAMENT MINISTRIES

INC., (hereinafter referred to as the "Ministry").

EFFECTIVE DATE

ARTICLE II. PURPOSE

The purpose and object of the Ministry shall be to teach and spread the gospel of Jesus Christ, in word, song and deeds, to utilize biblically based methodology in music, publishing, broadcasting, research, counseling and professional approaches to healing and ministering to the body, mind, and spirit. The Ministry shall also conduct any and all business consistent with the laws of the State of Florida and United States of America.
