Article I- Name of the corporation

Article II- Nature or purpose of the Business

The purpose of the Corporation is to engage in any lawful activity permitted by the law of Florida. **The primary function of the Corporation is to: Restore life of all individuals in our community. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 501 (c) (3) of the internal revenue service law.

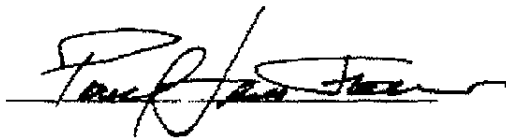
