C. The member(s) of each unit shall be entitled to cast the number of votes equivalent to the share of ownership in the common elements appurtenant to the unit, as follows:

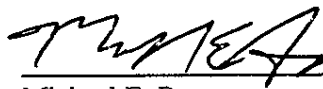

The votes of a units shall not be divided or cumulated. Voting rights shall exercised in accordance with the provision of these Articles of Incorporation and the By-Laws of the Association.

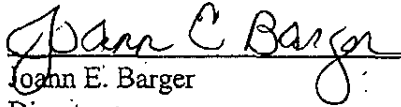
THIRD: The date of the above amendments adoption is January 2013.

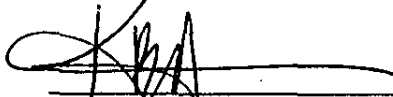

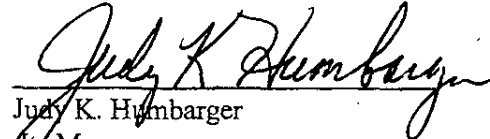
