## ARTICLES OF INCORPORATION OF SAXONY PLACE AT CARILL ON TOWNHOME OWNER'S ASSOCIATION, INC.

By these Articles of Incorporation, the undersigned incorporator forms a corporation not for profit in accordance with Chapter 617, Florida Statutes, and pursuant to the following provisions (the "Articles"):

## ARTICLE I

The name of the corporation shall be SAXONY PLACE AT CARILLON TOWNHOME OWNER'S ASSOCIATION, INC. For convenience, the corporation shall be referred to in this instrument as the "Association."

#### ARTICLE II DURATION

The Association shall exist perpetually unless and until dissolved according to law. Corporate existence of the Association shall commence upon the filing of these Articles with the Florida Department of State.

## ARTICLE IN DEFINITIONS

The term "Declaration" shall mean the DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR SAXONY PLACE AT CARILLON recorded or to be in the Public Records of Pinellas County, Florida, and all amendments or supplements made thereto from time to time. All other capitalized words and terms used in these Articles shall have the meaning and definition as provided in the Declaration.

#### ARTICLE IV PRINCIPAL OFFICE

The principal office of the Association is located at c/o Jay Gee Development, LLC, 2495 Johnna Court, Palm Harbour, Florida 34685

## ARTICLE V REGISTERED OFFICE AND AGENT

John Geiger, whose address is c/o Jay Gee Development, LLC, 2495 Johnna Court, Palm Harbour, Florida 34685, is hereby appointed the initial registered agent of the Association and the registered office shall be at said address.

#### ARTICLE VI PURPOSE AND POWERS OF THE ASSOCIATION

The Association is formed to provide for, among other things, the improvement, maintenance, preservation and architectural control of the property, owned by the Association and/or subject to the Declaration and to promote the recreation, health, safety and welfare of the Owners and any other purpose under the Declaration. The Association shall have all the powers of a non-profit corporation organized under the laws of the State of Florida, subject only to such limitations upon the exercise of such powers as are expressly set forth in these Articles, the Bylaws, the Declaration or by law.

#### ARTICLE VII DIRECTORS AND OFFICERS

The affairs of this Association shall be managed by a Board of Directors, and the affairs of the Association shall be administered by the Officers holding the offices designated in the Bylaws. All matters regarding the Directors and the Officers of the Association, including numbers, election, duration, etc., shall be governed in accordance with the provisions set forth in the Declaration and in the Bylaws.

### ARTICLE VIUI INDEMNIFICATION

8.1 Every director and every officer of the Association shall be indemnified by the Association against all expenses and liabilities, including counsel fees, reasonably incurred by or imposed upon him in connection with any proceeding whether civil, criminal, administrative or investigative, or any settlement of any proceeding, or any appeal from such proceeding to which he may be a party or in which he may become involved by reason of his being or having been a director or officer of the Association, or having served at the Association's request as a director or officer of any other corporation, whether or not be is a director or officer at the time such expenses are incurred, regardless of by whom the proceeding was brought, except in relation to matters as to which any such director or officer shall be adjudged liable for gross negligence or willful misconduct, provided that in the event of a settlement, the indemnification shall apply only when the Board of Directors of the Association approves such settlement and reimbursement as being for the best interest of the Association. The foregoing right of indemnification shall be in addition to and not exclusive of all other rights to which such director or officer may be entitled.

- 8.2 Expenses incurred in defending a suit or proceeding whether civil, criminal, administrative or investigative may be paid by the Association in advance of the final disposition of such action, suit or proceeding if authorized by all of the non-interested directors upon receipt of an undertaking by or on behalf of the director or officer to repay such amount if it shall ultimately be determined that he is not to be indemnified by the Association as authorized by these Articles of Incorporation.
- 8.3 The Association shall have the power to purchase at its expense and maintain insurance on behalf of any person who is or was a director or officer of the Association, or is or was serving at the request of the Association as a director or officer of another association, against any liability asserted against him and incurred by him in any such capacity, or arising our of his status as such, whether or not the Association would have the power to indemnify him against such liability upder the provisions of these Articles.

## ARTICLE IX

The initial Bylaws of the Association shall be adopted by the Board of Directors and may be altered, amended or rescinded in the manner provided by the Bylaws.

## ARTICLE XI NONSTOCK CORPORATION

The Association is organized on a non-stock basis and shall not issue shares of stock evidencing membership in the Association; provided, however, that membership in the Association may be evidenced by a certificate of membership which shall contain a statement that the Association is a corporation not for profit.
