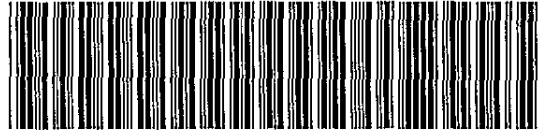

**ARTICLE I.**  
**NAME**

The name of the corporation is: Homeowner Associations of Alachua County, Inc.

**ARTICLE II.**

**ARTICLE III**  
**PURPOSE**

The purpose of this corporation as organized is to improve home ownership by improving the positive impact a homeowner/condominium association and/or neighborhood group can have on a neighborhood by improving communications between homeowners and neighborhoods; ensuring service providers understand the needs of specific neighborhoods; ensuring the best interests of the homeowners are protected against adverse influences injected by developers and realtors; having a positive influence on the organization of future neighborhoods by communicating homeowner expectations to developers; educating association board members, committee members and homeowners on statutes, city and county ordinances and protocol; and ensuring neighborhood/association resources are used most effectively and efficiently by pooling neighborhood/association resources and executing/fulfilling the service needs of each neighborhood/association as an organized group.

This corporation shall have perpetual existence.



## ARTICLE X BY-LAWS



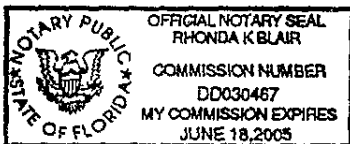
