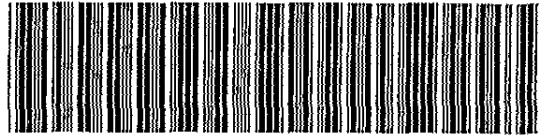

**ARTICLES OF INCORPORATION OF

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the Not for Profit corporation shall be:

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

To provide charitable and educational programs pursuant to §501(c)(3) of the IRC., to wit:
