**Article I - Name**

The name of the corporation shall be American Wildlife Conservancy, Inc.

**Article II - Principal Office**

The principal place of business and mailing address of this corporation shall be 7610 Granville Dr., Ft. Lauderdale, Florida 33321.

**Article III - Purpose**

The purpose for which the corporation is organized is: to promote and foster Florida's environment by endorsing compliance with federal, state and local laws regarding the protection of natural resources and promoting environmental education and awareness with a view towards preserving the environment for future generations and to promote and foster the protection of animals, both wild and domesticated, within and out of the community through education, shelter, assistance, relief, comfort and sanctuary for all animals.

This corporation is organized exclusively for educational and scientific purposes and shall operate strictly in such a manner as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code or corresponding provisions of any subsequent federal tax laws.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (2) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future tax code.

**Article IV- Manner of Election**

The manner in which the directors are elected or appointed:

The initial directors, which will number not less than three, shall be elected at the initial meeting of the corporation. Thereafter, the manner of election of directors shall be

stated in the by-laws of the corporation. Officers will be appointed by the Board of Directors.

**Article V- Initial Directors and/or Officers**
