The undersigned for the purpose of forming a corporation not for profit under Chapter 617, Florida Statutes hereby adopt the following Articles of Incorporation:

1. The name of this corporation shall be: _____

Chapel 960 of Alliance of Divine Love, Inc.

2. The corporation is to have perpetual existence and the corporate existence will commence on the filing of these articles by the Department of State.

3. The purpose of this corporation is as follows:

- a. to provide participants appropriate treatment for addiction, co-dependency and trauma.
- b. To give spiritual guidance to participants for the healing process.
- c. To teach participants a process for resolving painful issues and to develop a spiritual program for daily living.
- d. To perform all functions as a minister ordained by the Alliance of Divine Love, Inc.
- e. To conduct its business, carry on its operations and exercise powers granted it by the State of Florida and the United States of America.



10. Nothing in these Articles of Incorporation shall be deemed to limit the powers of this corporation.

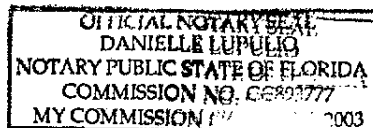


