The undersigned subscribers of these Amended Articles of Incorporation, being natural persons competent to contract, hereby subscribe to and form a corporation not for profit under the laws of the State of Florida.

ARTICLE I Name and Principal Office

The name of the corporation is Bratpack Rescue, Inc., a Non-Profit Corporation, and it shall have as its principal address is 1745 Lake Terrace Drive, Eustis, Florida 32726 and mailing address is 1745 Lake Terrace Drive, Eustis, Florida 32726.

ARTICLE II

The corporation is to exist perpetually, with commencement at the time of filing these Articles.

ARTICLE III Purpose

The purpose or purposes for which the corporation is organized are:

- 1. For the rescue, rehabilitation and re-homing of dogs and the advancement of charitable, educational and any other related or corresponding charitable purposes by the distribution of its funds for such purposes.
- 2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act, or engage in any other trade or business which can, in the opinion of the Board of Directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
- 3. To do such other things that are incidental to the foregoing or necessary or desirable to accomplish the foregoing.
- 4. Further, the corporation is exclusively, charitable, scientific, literary, and educational within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Any person eighteen (18) years of age and over, evidencing a willingness to work toward the goals of the organization may be accepted to regular membership on approval of the Board of Directors.
