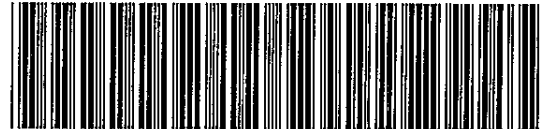

**Articles of Incorporation** of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, pursuant to Chapter 617, Florida Statutes, do hereby certify:

**ARTICLE I** – The name of the corporation shall be *Poinciana Scouting Corporation*.

**ARTICLE II** – The place in this state where the principal office of the Poinciana Scouting Corporation is to be located in the unincorporated community of Poinciana, Osceola County, and whose mailing address shall be:

**ARTICLE III** – Said corporation is organized for the purpose of education of young boys about character building, personal responsibility, morals, personal growth, and leadership. The development of these character traits will help young boys become responsible adults and will help to prevent community deterioration and juvenile delinquency through the guidelines, programs, and organizational structure of the Boy Scouts of America. The Poinciana Scouting Corporation shall be comprised of Cub Scout Pack 276 and Boy Scout Troop 276, which is registered in the Lake District of the Gulf Ridge Council, Tampa, Florida, and whose Chartering Organization is the Association of Poinciana Villages.

**ARTICLE IV** – Members of the Board of Directors shall be elected during an annual meeting of parents of current registered Cub Scouts and Boy Scouts and current registered leaders in January of each year. Nominations shall be made from the floor and voting of the Board of Directors shall come from the parents of currently registered Cub Scouts and Boy Scouts and registered leaders during the annual meeting. Each Director shall be elected by a simple majority of ballots cast conducted by secret ballot. The Chartering Organization member of the Board of Directors shall be appointed by the Association of Poinciana Villages Manager.

**ARTICLE VI** – No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code.

**ARTICLE IX** – Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
