Articles of Incorporation
Of
For the Love of Greyhounds, Inc.
A Florida Not-For- Profit Corporation

The undersigned, acting as the incorporator of a not for profit corporation under the Florida Not For Profit Act, as set forth in Chapter 617 of the Florida Statutes, as amended, adopts the following Articles of Incorporation for such Corporation.

Article I: Name

The name of the Corporation shall be For the Love of Greyhounds, Inc. Hereinafter referred to as the "Corporation"

Article II: Principal Office and Mailing Address

The address of the principal office of the Corporation is and the mailing address of the Corporation is 6207 108th Avenue, Pinellas Park, Florida 33782, in Pinellas County.

Article III: Duration

The period of duration of the Corporation shall be perpetual unless dissolved according to law.

Article IV: Purposes

The purposes of this not for profit corporation is to educate the public, facilitate and promote the adoption of Greyhounds. Not-Withstanding any other provisions of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (I) be a corporation exempt from federal income tax under Section 501 (C) (3) of the Internal Revenue Code of 1985, (or the corresponding provisions of any future United States Internal Revenue Law), or (II) by a corporation, contributions to which are deductible under Section 170 (C) (2) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue Law.)

Article V: Restrictions on Activities

No substantial part of the activities of this corporation shall consist of carrying on of propaganda or otherwise attempting to influence legislation, nor shall this corporation participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of (or in opposition to) any candidate for public office.

Article VI: Membership

The corporation shall be an all volunteer organization composed of those persons listed as the board of directors and all other persons wanting to volunteer as provided in the bylaws.

Article VII: Registered Office and Agent

The Corporation's registered office shall be located at 6207 108th Avenue, Pinellas Park, Florida 33782, and Stacy Korte is the registered agent of the Corporation at that address.

Article VIII: Board of Directors

The Board of Directors shall consist of three (3) persons. The number of directors may be increased or decreased from time to time by an amendment to the bylaws; however there shall never be less than three directors. All directors shall be selected as provided for in the bylaws. Their term of service shall be perpetual.

Article IX: Advisory Committee

The Advisory Committee shall consist of no less than three (3) persons including the Vice President, the Secretary/Treasurer, and such other officers as may be provided by the bylaws. They will aid the President in decision making.

Article XI: Distribution Of Assets Upon Dissolution

The property of this corporation is irrevocably dedicated to charitable and educational purposes and no part of the net income or assets of this corporation shall ever inure to the benefit on any Director, officer or member thereof. Upon dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable and educational purposes and which has established its tax exempt Status under Section 501 (C) (3) of the Internal Revenue Code.

Article XII: Incorporator

The incorporator of the Corporation is Stacy Korte and her address is 6207 108th Avenue, Pinellas Park, Florida 33782.

Article XIII: Non-Stock Basis

This Corporation is organized and shall be operated on a non-stock basis within the meaning of the Florida Not-for-Profit Corporation Act, and shall not have the power to issue shares of any type of class of stock. The Corporation may issue membership certificates of so provided in the bylaws.

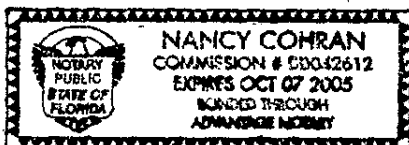
