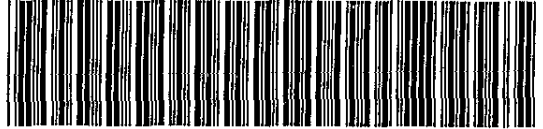

The undersigned, for the purpose of forming a corporation not for profit under the laws of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I

Name of Corporation

The name of the corporation is Gables IB Parent Organization, Inc.

ARTICLE II

Place of Business and Mailing Address

The initial principal place of business and mailing address of the corporation is 6271 SW 44th Street, Miami, FL 33155

ARTICLE III

Nature of Business

This corporation is organized for the sole purpose of fostering and supporting the Coral Gables High School International Baccalaureate Program with the specific intent to limit its purpose in order to qualify for the exemption provided under Internal Revenue Code 501 (c) (3). In the event the corporation dissolves, any and all assets of the corporation shall be transferred to a successor corporation established for the same purpose or to the Coral Gables High School International Baccalaureate Program for use in supporting the program's students.
