A NON-PROFIT CORPORATION

We, the undersigned for the purpose of forming a corporation under and pursuant to Chapter 617.0202, of the Laws of the State of Florida, do hereby associate as a body corporate and adopt the following Articles of Incorporation.

Article I Name and Address

The name of this corporation shall be: WINNERS ASSEMBLY INTERNATIONAL CHURCH, INC. The principal place of business shall be 10329 Cross Creek Boulevard, Suit D, Tampa, FL 33647 while the mailing address of the corporation shall be P. O. Box 47376, Tampa, FL 33647.

Article II General and Specific Purposes

The Purposes of this Corporation shall be:

- A. To propagate the Gospel of our LORD and Savior, Jesus Christ throughout the world and advance His Kingdom. The Church shall seek to attain this end through the public worship of God, the preaching of the Gospel, consistent Christian living by its members, personal evangelism, missionary endeavor, and Christian education;
- B. This Church shall be and is incorporated in accordance with the Laws of the State of Florida as a non-profit charitable, religious, and educational corporation within the scope of Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law);
- C. The corporation is organized and operate exclusively in any other manner for such religious, educational, charitable and scientific purposes as will qualify it as an Exempt Organization under Section 501 (c)(3) of the Internal Revenue Code of 1954 as amended or under corresponding provision of any subsequent Federal Income Tax Laws covering the distributions to organizations qualified as Tax-Exempt organizations under the Internal Revenue Code.

Article III Membership and Management

The corporation shall have members. The qualifications for membership and the manner of their admission are general, (no specific qualifications) shall be as set forth in the Constitution and Bylaws of this corporation.

The management, conduct and control of the business of this corporation shall be vested in the body of believers who compose it as represented by a Board of Directors, consisting of not less that three members and not more than a maximum number as provided for in the Bylaws of this corporation. The Directors constituting the first Board of Directors of the corporation shall be three (3) and the tenure in office of such first Board shall be as long as practicable or until successors are elected and qualified at the first annual meeting. The election into and removal from office procedures are as stated in the Bylaws of this corporation. The names and addresses of each first Director are as follows:

Article V Earning And Activities Of Corporation

- (a). No part of the earnings of this corporation shall inure to the benefit of, or be distributed to its members, Trustees, Directors, Officers, or any other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of the purpose set forth in this Article of Incorporation.
- (b). No substantial part of the activities of the corporation shall be carrying on of propaganda or otherwise attempting to influence legislation and the corporation shall not participate in or intercede in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.
- (c). Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Code), to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 or any corresponding provisions of any United States Revenue law.

(d). Notwithstanding any other provisions of these Articles, this corporation shall not accept to an insubstantial degree, engage in any activities or exercise any power that are not in furtherance of the purpose of this corporation.

Article VI Dissolution

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for payment of all liabilities of the corporation, transfer all assets to a fund, foundation, or organization which is organized and operated exclusively for charitable, educational, or religious organization which is recognized and at the time qualify as an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law).
