**ARTICLES OF INCORPORATION
OF
EKKLESIA INTERNATIONAL COMMUNITY OUTREACH
CENTER, INC.**

ARTICLE I - NAME OF CORPORATION

The name of the not-for-profit corporation shall be EKKLESIA INTERNATIONAL COMMUNITY OUTREACH CENTERS, INC.

ARTICLE II - DURATION

The not-for-profit corporation shall have a PERPETUAL existence unless dissolved according to law. Corporate existence shall commence upon filing of Articles of Incorporation with the Secretary of State for the State of Florida.

ARTICLE III - PURPOSE OF CORPORATION

The not-for-profit corporation is organized exclusively for religious, charitable, scientific, literary and educational purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986, or corresponding section of any future federal tax code, or shall be distributed to the Federal, state or local government for a public purpose. Any assets not so disposed of shall be disposed of by the Court of Common Pleas, of the county in which the principal office of the corporation is then located, exclusively for such purposes.

The general nature and objectives of this corporation shall be as follows:

- 1) To provide housing and after school care for unwed teenage pregnant mothers who reside in housing projects or other low income neighborhoods.

ARTICLE IV - INITIAL REGISTERED AGENT AND OFFICE

The name of the not-for-profit corporation's initial registered agent is Rev. Diane C. Pope. The address of this not-for-profit corporation's registered agent and principal place of business is 4151 N.W. 135th Street, Opa Locka, Florida 33054

ARTICLE V - CAPITAL STOCK

This is a not-for-profit corporation and therefore it will not have capital stock.
