Delete: The name of the Corporation shall be: AyokaGifts African International Server Inc.

This corporation is organized exclusively for charitable, religious, educational and scientific purposes, and for such purposes, the making of distributions to organizations that qualify as exempt under section 501 (c) 3 of the Internal Revenue Code of 1986, or the corresponding sections of any future federal tax code; including but not limited to 1) eradication of poverty, 2) Promotion and Preservation of African culture and art, 3) promote Socioeconomic development and 4) foster positive self image, self-sufficiency skills, cultural awareness in economically disadvantage youth, through the education and teaching of African culture, traditions, art, literature and film,
