# ARTICLES OF INCORPORATION ALLAHASSEE FLORIDA

The undersigned, acting as Incorporator(s) of Ocala Congars Pop Warner Football & Cheerleading, Inc., a corporation not for profit, under the Florida General Corporations Act, adopt(s) the following Articles of Incorporation for such corporation:

- 1. NAME: The name of this corporation is Ocala Cougars Pop Warner Footbell & Cheerleading, Inc.
- 2. PRINCIPAL OFFICE: The mailing address of this corporation shall be: 1710 SE 16 Avenue, Ocala, Florida 34471.
- 3. **PURPOSE:** This non profit corporation is organized for educational purposes for a youth sports organization
- 4. **QUALIFICATION OF MEMBERS:** Qualifications for membership will be determined in the by-laws.
- 5. <u>INITIAL REGISTERED OFFICE AND AGENT</u>: The street address of the initial registered office of this corporation is 1710 SE 16 Avenue, Ocala, Florida 34471 and the name of the initial registered agent of this corporation at that address is Michael H. Rotstein.

Any of such assets not so disposed of shall be disposed of by the Circuit Court of the County in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
