# ADOPTED AMENDMENTS TO THE ARTICLES OF INCORPORATION OF VILLAS OF CARILLON HOMEOWNERS ASSOCIATION, INC.

The following are adopted amendments to the Articles of Incorporation of Villas of Carillon Homeowners Association, Inc., attached as an exhibit to the Declaration of Covenants, Conditions and Restrictions of Villas, originally recorded at Official Records Book 13434, Page 720, Public Records of Pinellas County, Florida, and as subsequently amended.

(New Wording <u>Underlined</u>; Deleted Wording Stricken Through, Except When Proposed Amendment Involves Substantial Rewording)

Item No. 1: Article II, Article VI and Article VII of the Articles of Incorporation are hereby amended to read as follows:

### ARTICLE II PRINCIPAL OFFICE

The principal office of the Association is located at <u>such place designated by the Board of Directors from time to time 301-S. MacDill Avenue, Tampa, FL 33609, which shall be the initial registered office of the Association.</u>

## ARTICLE VI VOTING RIGHTS

(substantial rewording; see same section of existing Declaration for current wording)

Members shall be entitled to one vote for each Unit in which they hold the interest required for membership; provided, however, there shall be only one vote per Unit. Where more than one person or entity shall at any time be the Owner of a Unit, the vote allocable to such Unit shall be exercised as such Owners mutually determine. Any one of multiple Owners of a Unit may exercise the voting rights on behalf of the Unit, provided that if the multiple Owners cannot agree how to vote, and attempt to cast votes which are in conflict with those cast by another Owner, the vote for this Unit will not be counted. The vote of an Owner which is not a natural person shall be cast by any officer of a corporation, or any partner or managing agent of another type of entity who is authorized to vote on behalf of such entity.

# ARTICLE VII BOARD OF DIRECTORS

The affairs of the Association shall be managed by a board of not less than three (3) Directors nor more than seven (7), with the additional requirements and details to be provided in the Bylaws of the Association and the Florida Statutes who need not be members of the Association (the "Board"). The initial number of directors shall be three (3) and may be changed by amendment of the Bylaws of the Association. The names and addresses of the persons who are to act in the capacity of directors until the election of their successors are:
