ARTICLES OF INCORPORATION **OF**

A FLORIDA NOT-FOR-PROFIT CORPORATION The undersigned, acting as the incorporator of a not for profit corporation under the Florida Not For Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, as

ARTICLE I: NAME

The name of the Corporation shall be New Providence Development Center, Inc. hereinafter referred to as the "Corporation".
