The name of this corporation shall be IGLESIA EVANGELICA PENTECOSTES EL CORDERO DE DIOS, INC.

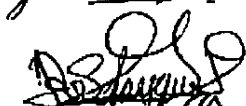
ARTICLE V. PRINCIPAL OFFICE
