THE UNDERSIGNED, in order to form a corporation not-for-profit under the provisions of Chapter 617, Florida Statutes, hereby executes and files these Articles of Incorporation.

The name of the corporation is VILLAGE PROFESSIONAL PARK PROPERTY OWNERS ASSOCIATION, INC. (the "Association") and its principal office and mailing address are c/o Colony Realty, Inc. 12230 Forest Hill Blvd., Suite 101, Wellington, FL 33414.

The term for which the Association is to exist is perpetual unless it is dissolved pursuant to any applicable provision of Florida Statutes.
