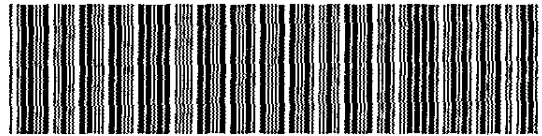

I.

The name of the corporation shall be: GLOBAL FOUNDATION FOR CHILDREN WITH AIDS, INC.

II.

A. This Corporation is a nonprofit public benefit Corporation and is not organized for the private gain of any person. It is organized in compliance with Chapter 617 of the Florida Statutes as a charitable organization.

B. The specific purpose of this Corporation is to act and operate as a charitable and educational organization to address and support research into and treatment of infections and other diseases affecting children worldwide.

III.

The principal place of business and mailing: 50 3<sup>rd</sup> Avenue, SW, Boca Raton, Florida 33432.

IV.

The Board of Directors shall be elected each year at the annual meeting of the Board of Directors by majority vote at a meeting at which a quorum is present as further set forth in the Bylaws of the Corporation.

V.

The name and address in the State of Florida of this Corporation's registered agent is: Craig Copland, 50 3<sup>rd</sup> Avenue, SW, Boca Raton, Florida 33432.

VI.

The name and address of the Incorporator is: Craig Copland, 50 3<sup>rd</sup> Avenue, SW, Boca Raton, Florida 33432.

VII.

This Corporation is organized and operated exclusively within the meaning of Section 501(c)(3) of the Internal Revenue Code. No substantial part of the activities of this Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the

Corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

VIII.

The property of this Corporation is irrevocably dedicated to public purposes and no part of the net income or assets of this Corporation shall inure to the benefit of any director, officer or member thereof or to the benefit of any private person. Upon the dissolution of the Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this Corporation shall be distributed to a nonprofit fund, foundation or Corporation which is organized and operated exclusively for public and charitable purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code pursuant to the Bylaws of the Corporation.

Having been named as registered agent to accept service of process for the above stated Corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
