Pursuant to the provisions of section 617.1006, Florida Statutes, this *Florida Not For Profit Corporation* adopts the following amendment(s) to its Articles of Incorporation:

**AMENDMENTS ADOPTED: ARTICLE IV – DIRECTORS**

**Added:**

**Article IV – a) Compensation of Directors and Officers.**

The Directors and Officers of the Board shall perform the incumbent duties of their offices without salary. No part of the net earnings of the association shall go to the benefit of trustees, officers or other private persons. But the Board of Directors may authorize payment by the Association of reasonable expenses incurred by the Directors in the performance of their duties and of reasonable compensation for special services rendered by any Director.

**b) Political Campaign and Lobbying**

No substantial part of the activities of the organization shall be the carrying of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. The organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

**c) Dissolution**

Upon dissolution of ADSAA, after payment of, or provision for payment of, all debts and liabilities, the remaining assets of the association shall be disposed of exclusively to the Ethiopian Community Association in Central Florida, a nonprofit association, organized and operated exclusively for charitable purposes of Ethiopians residing in Florida which has established its tax exempt status under Florida law and is qualified under Section 501(c)(3) of the Internal Revenue Code.


