ARTICLES OF INCORPORATION OF

**Orlando Resource Group, Inc.
A Florida Not for Profit Corporation**

In Compliance with Chapter 617, Florida Statutes (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be: Orlando Resource Group, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE

The purpose for which the corporation is organized is: exclusively for charitable and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

More specifically, the Corporation hopes to educate those who are interested in an internal experience reached through learning and practicing certain self-knowledge techniques. The Corporation will sponsor events, meetings, training sessions, and practice sessions relating to the understanding and enjoyment of the internal experience reached through these techniques.

The property of this Corporation is irrevocably dedicated to charitable purposes. No part of the net income or assets of the Corporation shall inure to the benefit of, or be distributed to any director, officer, trustee, member, or other private person, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered. No substantial part of the activities of the Corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code or the corresponding section of any future federal tax code; (b) by a Corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code or the corresponding section of any future federal tax code; or (c) under the provisions of Chapter 617 of the Florida Not For Profit Corporation Act.

ARTICLE IV TERM OF EXISTENCE

The duration of the Corporation shall be perpetual.

ARTICLE V DIRECTORS

Section 1: Number. This Corporation shall have five (5) directors. The number of directors may be increased or diminished from time to time in accordance with the bylaws, but shall never be less than three (3). The method of election of the directors shall be as stated in the by-laws.
