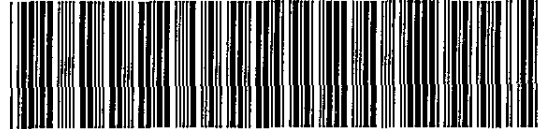

- Three: This Corporation is a non profit public benefit corporation and is not organized For the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for, charitable and educational Purposes to aid students, the elderly and community service projects. The Programs will consist of but shall not be limited to: academic scholarships, Programs for the elderly, Educational programs and other programs to aid Those in need.


Seven:

Eight: The property of this corporation is irrevocably dedicated to Charitable and Educational Purposes. No part of the net income or assets of the organization Shall ever insure to the benefit of any director, officer or member thereof or the Benefit of any private person.

Nine: On the dissolution or winding up of the corporation, its assets remaining after Payment of, or provision for any payment of, all debts, and liabilities of this Corporation, shall be distributed to a nonprofit fund, foundation, or corporation, That is organized and operated exclusively for, Educational and Charitable under Section 501(C)(3) the Internal Revenue code.
