

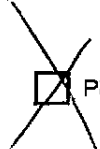

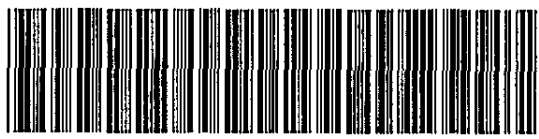

Pursuant to the provisions of section 617.1006, Florida Statutes, FLORIDIANS FIRST, INC. (the "Corporation") adopts the following Articles of Amendment to its Articles of Incorporation:

**FIRST:** The name of the Corporation was FLORIDIANS FIRST, INC. The new name of the Corporation is AMERICANS PROTECTING FAMILY VALUES, INC.

**SECOND:** Article I is hereby deleted in its entirety and is hereby replaced and superseded by the following new Article I.

ARTICLE I

Name and Address

The name of the Corporation shall be AMERICANS PROTECTING FAMILY VALUES, INC. and the address of the Corporation is 12882 SW 60<sup>th</sup> Terrace, Miami, Florida 33183.

**THIRD:** Article III is hereby deleted in its entirety and is hereby replaced and superseded by the following new Article III.

ARTICLE III

Stock/Members

The Corporation shall not issue shares of stock, but shall consist of non-stock owning members who shall be admitted as set forth in the bylaws of the Corporation. The members of the Corporation shall be Julio Jarramillo, Julio Naranjo and Jarnette G. Rodriguez.

**FOURTH:** Article VI is hereby deleted in its entirety and is hereby replaced and superseded by the following new Article VI.

ARTICLE VI

Address of Registered Office and Registered Agent

The address of the registered office of the Corporation in the State of Florida shall be 12882 SW 60<sup>th</sup> Terrace, Miami, Florida 33183. The name of the registered agent of the Corporation at the above address shall be Julio Naranjo. The Board of Directors may from time to time change the registered office to any other address in the State of Florida or change the registered agent.

**FIFTH:** Article VIII is hereby deleted in its entirety and is hereby replaced and superseded by the following new Article VIII.

ARTICLE VIII

Board of Directors

The Board of Directors shall consist of three members. The name and street address of the members of the Board of Directors of the Corporation, who shall hold office until the first annual meeting of the members, and thereafter until their successors have been elected and qualified are as follows:



**SEVENTH:** There are no members or members entitled to vote on the amendments. The amendments were adopted by the Board of Directors.

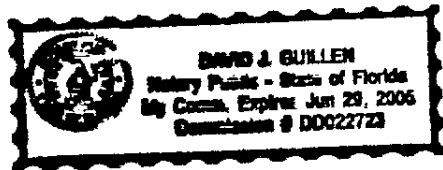
