## FIRST AMENDMENT TO ARTICLES OF INCORPORATION OF NOT CORPORATION VALENCIA PALMS PROPERTY OWNERS' ASSOCIATION DEC 28 AM 11: 26

(A Florida corporation not for profit)
Pursuant to Section 617.1002 of the Florida Not For
Profit Corporation Act

The undersigned, being the Declarant under that certain Declaration of Covenants, Restrictions and Easements for Valencia Palms ("Declarant") desires to amend the Articles of Incorporation for the Valencia Palms Property Owners' Association, Inc., a not for profit corporation ("Association"), as follows:

- 1. The Association was originally incorporated on May 28, 2004, Charter Number N0400005412, under Chapter 617 of the laws of the State of Florida.
- 2. Declarant wishes to amend the Articles in accordance with the requirements of Article XIII of the Articles which provides that prior to the First Conveyance (as defined in the Articles) the Articles may be amended only by an amendment in writing signed by Declarant and filed with the Secretary of State of the State of Florida.
  - 3. The First Conveyance has not yet occurred.

NOW, THEREFORE, the Articles are hereby amended as follows:

1. Article I.17 the Articles is hereby amended to read as follows:

"Valencia Palms" means the planned residential development located in Palm Beach County, Florida, which encompasses the Property and is presently planned to contain approximately five hundred eighty two (582) six hundred twelve (612) Homes and Association Property thereon, but subject to change in accordance with the Declaration. Although Valencia Palms is governmentally approved for six hundred twenty-five (625) Homes and Association property, if and when fully developed, Valencia Palms is presently intended to comprise approximately five hundred eighty two (582) six hundred twelve (612) Homes and Association Property.

2. Article X.C of the Articles is hereby amended to read as follows:

Valencia Palms is presently planned to contain approximately five hundred eighty two (582) six hundred twelve (612) Lots with a Home constructed on each Lot if and when fully developed ("Developed Lots"). However, Valencia Palms is currently approved for six hundred twenty-five (625) Homes. For purposes of this paragraph, "Total Developed Lots" shall mean the five hundred eighty two (582) six hundred twelve (612) Developed Lots which Declarant intends to developer in Valencia Palms. Notwithstanding the foregoing, Declarant has reserved the right in the Declaration to modify its plan of development for Valencia Palms and to add land to and withdraw land from Valencia Palms and, therefore, the total number of Lots and Homes within Valencia Palms, and thus the "Total Developed Lots," may refer to a number greater or lesser than five hundred eighty two (582) six hundred twelve (612).
