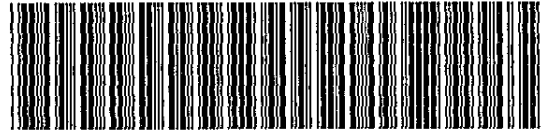



TO  
ARTICLES OF INCORPORATION

Pursuant to Section 617 Florida Statutes, the undersigned corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is:

***SAINTS CHRISTIAN HOMESCHOOL ATHLETIC ASSOCIATION, INC.***

SECOND: The following amendment of the Articles of Incorporation was adopted by the corporation:

ARTICLE THREE: Article Three is amended to read:

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, but not limited to, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. In addition, this corporation is organized to award scholarships, sponsor special needs fitness programs, assist with academic tutoring and/or to sponsor fitness and sports programs for homeschooled children, and any and all allowable activities of a non-profit 501 (c) (3) organization.

THIRD: This amendment was adopted by all trustees and directors of The Corporation on this 16<sup>th</sup> day of March, 2005. There are **no members**.
