Articles of Incorporation

The undersigned, all of whom are citizens of the United States, desiring to form a Not for Profit Corporation under the Not for Profit Corporation Laws of the State of Florida, do hereby certify:

ARTICLE I

The name of this Florida Not for Profit Corporation is:

Homeless Village of the Lower Keys, Inc.

ARTICLE II

The place in this state where the principal office of the Corporation is to be located is The City of Key West, Monroe County, Florida.

Mailing address will be: G-30 Roberta Street, Key West, Florida 33040

ARTICLE III

The purpose for which the corporation is organized is exclusively for charitable and educational purposes relative to the alleviation of homelessness in Monroe County, Florida. Primary activity will include provision of shelter and other services to homeless people and may include advocating for and supporting other programs and services which have as their goal, or are likely to result in, a reduction or alleviation of homelessness in Monroe County, Florida. Other activities may include seeking funding from public and private sources for the provision of services to the homeless.

ARTICLE IV

The method of electing or appointing Directors of this Corporation shall be by simple, majority vote of the current Directors and shall be set forth in the By Laws of this Corporation. The names and addresses of the persons who are the initial Directors of the corporation are as follows:

ARTICLE V

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to its members, Directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VIII


Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


