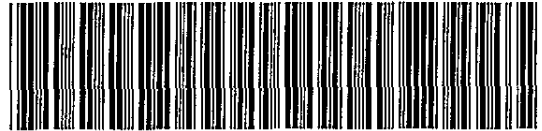

**ARTICLES OF INCORPORATION  
OF  
REVIVE MINISTRIES, INC.**

In Compliance with Chapter 617, Florida Statutes (Not for Profit), the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following Articles of Incorporation.

**ARTICLE I - NAME**

The name of this corporation is Revive Ministries, Inc.

**ARTICLE II – PRINCIPAL OFFICE AND MAILING ADDRESS**




