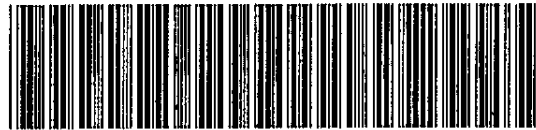

Miscellaneous Provisions

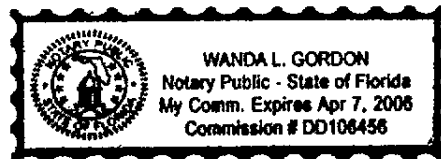
