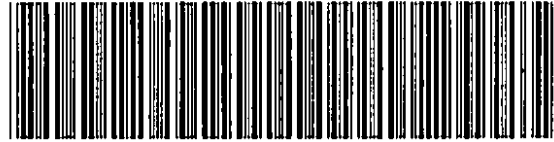

NOTICE IS HEREBY GIVEN that the Articles of Incorporation of THE CABRILLO CONDOMINIUM ASSOCIATION, INC., a Florida corporation not for profit, as originally filed on July 22, 2004, with the Secretary of State of the State of Florida, were amended by approval of not less than sixty-seven percent (67%) of the votes of all of the members of the Association at the Annual Meeting of Members on March 14, 2022, and by unanimous approval of the entire Board of Directors at the Special Meeting of the Board on June 24, 2022, as required for amendment of said Articles of Incorporation, as set forth below:

Section 10.1 of Article X of the Articles of Incorporation is amended to read as follows:

**ARTICLE X
DIRECTORS**

10.1 Number and Qualifications. The property, business and affairs of the Association shall be managed by a Board consisting of the number of Directors determined by the By-Laws. Directors must be members of the Association.
