The undersigned Incorporator hereby adopts the following Articles of Incorporation for the purpose of forming a not for profit corporation pursuant to the Florida Not For Profit Corporation Act.

#### **ARTICLE I**

#### Name

The name of the Corporation ("Corporation") shall be:
