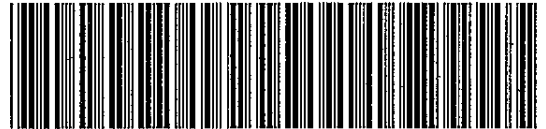

**ARTICLES OF INCORPORATION**

In compliance with Chapter 617, F.S., (Not for Profit)

The undersigned incorporator, in order to form a non-profit corporation under the laws of the State of Florida, adopts the following Articles of Incorporation.

**Article I: Name**

The name of the corporation shall be **Senior Tennis of Volusia, Inc.**

**Article II: Principal Office**

**Article III: Purpose**
