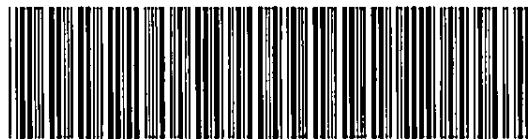


## PLAN OF DISTRIBUTION OF ASSETS
