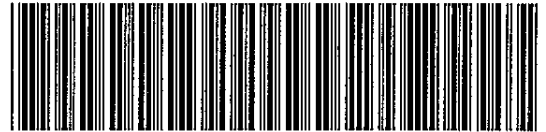

**ARTICLES OF INCORPORATION  
OF  
NORTHSIDE NEIGHBORHOOD COUNCIL  
A NOT-FOR-PROFIT CORPORATION**

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes adopts the following Articles of Incorporation.

**ARTICLE I**

**NAME OF COPORATION:** The name of the corporation shall be as follows:

No part of the earnings of the Corporation shall insure to the benefit of any member, Director or Officer of the Corporation or any other person, (except the paid staff of the corporation those

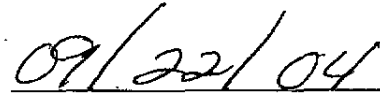

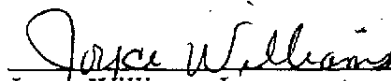
#### ARTICLE IX
