TO
ARTICLES OF INCORPORATION

Pursuant to Section 617, Florida Statutes, the Articles of Incorporation (the "Articles") of **SILVER PINES POINT PHASE III HOMEOWNERS ASSOCIATION, INC.**, are hereby corrected as follows:

1. The name of the Corporation is **SILVER PINES POINT PHASE III HOMEOWNERS ASSOCIATION, INC.** (the "Association").
2. The date of filing the Articles was October 22, 2004.

ARTICLE I


NAME OF CORPORATION
