**ARTICLES OF INCORPORATION**  
of  
**"GRACE" ROMANIAN BAPTIST CHURCH of NAPLES, Inc.**

We, the undersigned, acting as the incorporators of a corporation under the provisions of the state Nonprofit Corporation Law hereby signed and verified the following Articles of Incorporation for such corporation.

**ARTICLE I: NAME**

The name of the corporation shall be:

**ARTICLE II: PRINCIPAL OFFICE**

**ARTICLE III: PURPOSES and POWERS**

Section 1. PURPOSES The purposes for which this corporation is organized are exclusively religious, not for profit, charitable, educational and they are the following:

- To be a place for Romanian Community to worship God.
- To be a place for God's Gospel to be preached in a relevant way in accomplishing the Great Commission.
- To be a place where Romanian people have fellowship with God.
- To be a place for discipleship of God's people.
- To be a place for sharing God's love by serving one another.
- To aid, support and assist by gifts, donations, offerings or otherwise, other corporations, community chests, funds and foundations organized and operated exclusively for charitable, scientific or educational purposes, no part of net earnings of which inures to the benefit of any private shareholder or individual, and no substantial part of the activities of which is carrying on propaganda, or otherwise attempting to influence legislation.
- To do any and all lawful activities which may be necessary, useful or desirable for the furtherance, accomplishment, fostering or attainment of the foregoing purposes, either directly or indirectly and either alone or in conjunction or cooperation with others, whether such others be persons or organizations of any kind or nature, such as corporations, firms, associations, trusts, institutions, foundations, or governmental bureaus, departments, or agencies.

Section 2. POWERS In general, and subject to such limitations and conditions as are or may be prescribed by law of the corporation shall have all powers which now or thereafter are conferred by law upon a corporation organized for the purposes set forth above, or are necessary or incidental to the powers so conferred, or are so conducive to the attainment of the corporation's purposes.




