

ARTICLES OF INCORPORATION

OF

FLORIDA JUSTICE REFORM INSTITUTE, INC.

A Florida Not-For-Profit Corporation

ARTICLE I: NAME

Florida Justice Reform Institute, Inc.

ARTICLE II: LOCATION

The principal office and mailing address is:

ARTICLE III: PURPOSE

This corporation is established as a 501(c)(4) tax-exempt organization pursuant to the United States Internal Revenue Code of 1986.

This corporation shall be organized as a not-for-profit corporation under Chapter 617, Florida Statutes, and is to be exclusively devoted to the promotion of social welfare under Section 501(c)(4) of the Internal Revenue Code.

This corporation shall have no capital stock and shall not organize for the purpose of pecuniary gain or profit. No part of the net earnings of this corporation shall enure to the benefit of any private shareholder or individual nor shall any substantial part of its activities consist of carrying on propaganda or otherwise attempting to influence legislation, nor shall it participate in or

intervene in (including the publishing or distributing of statements) any political campaign on behalf of any candidate for public office.

ARTICLE IV: DIRECTORS

The method of selecting directors will be as provided in the bylaws.
