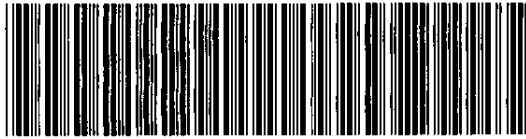

Amending Article 2 section G1: Upon the dissolution of the organized, assets shall be distributed for one or more exempt purpose within the meaning of section 501c3 of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to the state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purpose or to such organization, as said Court shall determine, which are organized and operated exclusively for such purposes.
