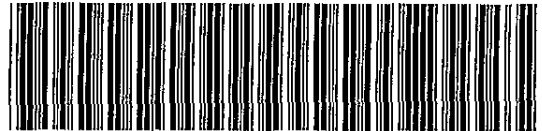

Article I through Article XIV shall be renumbered and retitled as follows: ARTICLE I NAME, ARTICLE II PRINCIPAL PLACE OF BUSINESS, ARTICLE III PURPOSES, ARTICLE IV BOARD OF DIRECTORS, ARTICLE V REGISTERED AGENT, ARTICLE VI OFFICERS, ARTICLE VII BY-LAWS, ARTICLE VIII EARNINGS AND NEGATION OF PECUNIARY GAIN, ARTICLE IX PROHIBITION OF CERTAIN ACTIVITIES, ARTICLE X FOUNDATION STATUS, ARTICLE XI INCORPORATOR, ARTICLE XII AMENDMENTS, and ARTICLE XIII DISSOLUTION.

2. Amended ARTICLE IV BOARD OF DIRECTORS shall be amended, removing Brian G. Cheslack as a member of the Board of Directors and appointing Hal Ellis Osborne in place thereof.

3. Amended ARTICLE V REGISTERED AGENT shall be amended, removing Brian G. Cheslack as registered agent and appointing Teri Jones, 1618 12 Oak Way, Apt 301, North Palm Beach, FL 33408 in place thereof.
