**ARTICLES OF AMENDMENT**  
**TO**  
**ARTICLES OF INCORPORATION OF**  
**SUMMERFIELD MASTER COMMUNITY ASSOCIATION, INC.**

Pursuant to the provisions of Section 617.1006, *Florida Statutes*, Summerfield Master Community Association, Inc., a Florida non-profit corporation (the "Association"), adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: Article VII of the Articles of Incorporation is hereby amended to read as follows:

**ARTICLE VII**

**VOTING RIGHTS**

A. This Association shall be a membership corporation, without certificates of shares of stock.

B. Qualification for, and admission to, membership in the Association shall be regulated by the Declaration and the Bylaws of the Association.

C. The share of an owner or a member in the funds and assets of the Association cannot be assigned, hypothecated or transferred in any manner, except as an appurtenance of such owner's or member's Lot. "

SECOND: Article XIV of the Articles of Incorporation is hereby amended to read as follows:

**ARTICLE XIV**

**AMENDMENTS**

These Articles may be amended by a vote of sixty-seven percent (67%) of the Voting Members present, in person or by proxy, at a meeting called for such purpose at which a quorum is present. "

THIRD: The date of adoption of the Amendment is effective as of December 31, 1999.
