ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF HANLEY-HAZELDEN CENTER AT ST. MARY'S, INC. FEB 17

1. Article II, Section 2, item (b)(v) of the Articles of Incorporation of HANLEY-HAZELDEN CENTER AT ST. MARY'S, INC., a finite Florida not-for-profit corporation, (the "Corporation") is hereby amended by deleting in its entirety and substituting in its stead the following:

"(v) Upon the dissolution of the Corporation, the Members of the Corporation shall, after paying or making provisions for the payment of all of the liabilities of the Corporation, dispose of all of the assets of the Corporation, one third (1/3) by fair market value to ST. MARY'S MEDICAL CENTER, INC., a Florida not-for-profit corporation, one third (1/3) by fair market value to the HAZELDEN FOUNDATION, a Minnesota not-for-profit corporation, and one third (1/3) by fair market value to HANLEY-HAZELDEN FOUNDATION, INC., a Florida not-for-profit corporation, each an exempt organization described in Section 501(c)(3) and 170(c)(2) of the Internal Revenue Code, or if any of the aforesaid corporations is not exempt from taxation under Section 501(c)(3) of the Code at the time of such disposition, then its share as set forth above shall be distributed at the direction of the Franciscans in the case of ST. MARY'S MEDICAL CENTER, INC., at the direction of the HAZELDEN FOUNDATION, in the case of its share, and at the discretion of HANLEY-HAZELDEN FOUNDATION, INC., in the case of its share, but in any case the assets shall only be distributed to organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future Internal Revenue Code or to the Federal, State or local government for exclusive public purpose. Any assets not so disposed of shall be disposed of by a court of competent jurisdiction exclusively for such charitable purposes, or to such organization or organizations organized and operated exclusively for such charitable purposes, as said court shall dotermine."

2. Article III, Section 2, item C. of the Articles of Incorporation of the Corporation are hereby amended by deleting it in its entirety and substituting in its stead the following:

"C. HANLEY-HAZELDEN FOUNDATION, INC., a Florida not-for-profit corporation."

3. The foregoing amendment was adopted b, the members of the Corporation on January 26, , 1987.
