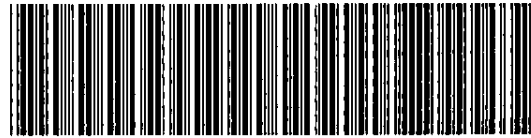

Upon dissolution of this organization, all assets will be used exclusively for exempt purposes within the meaning of Section 501(c)(3).




