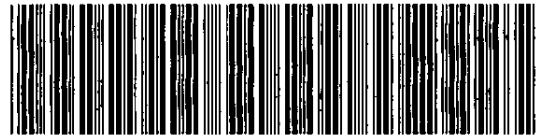

Pursuant to the provisions of section 617.1006, Florida Statutes, this **Florida Not For Profit Corporation** adopts the following amendments (s) to its Articles of Incorporation:

AMENDING OR ADDING ADDITIONAL ARTICLES

ARTICLE IV

OFFICERS

The manner in which the directors are appointed is as follows:

**a. Board of Directors**

This organization, as to its business affairs, shall be fully controlled, governed and operated by its Board of Directors, which shall consist of three (3) to twelve (12) members. The Board of Directors shall be a Pastor, Assistant Pastor, Secretary and Treasurer. Said officers shall be elected at the annual meeting of the church by a majority vote of the congregation.

**b. Principal Function of the Board**

1. To promote, under the direction of the senior pastor, the general and state outreach programs of the church.
2. To provide general supervision of the total operation of the church.
3. To work in harmony with the senior pastor and assist him when called upon in the institution and direction of the local church program.

4. To encourages the spirituality growth of the local congregation with emphasis on personal Bible reading, prayer, family devotions, tithing and giving, Christian service, and personal witnessing.

**c. Duties of the Board Members.**

1. **Pastor/President.** The Pastor shall be the principle executive officer of this Church Corporation and, subject to the control of the Board of Directors, shall in general supervise and control all of the business and affairs of the Church. He shall preside at all meetings of the Board of Directors and appoint all committees.
2. **The Assistant Pastor.** The Assistant Pastor/Vice President shall in the event of the absence or inability of the Pastor/President to exercise his office became acting president Pastor/President of the organization with all the rights, privileges and powers as if he had been the duly elected pastor/president. The Assistant Pastor/Vice President shall perform such other duties as from time to time may be assigned to him by the President or by the Board of Directors.
3. **Secretary.** The Secretary shall keep the minutes and records of the organization in the appropriate books. It shall be his/her duties to file any certificate required by any statute, federal or state. He/she shall submit to the Board of Directors any communications which shall be addressed to him/her as Secretary of the organization.
4. **Treasurer.** The Treasurer shall have the care and custody of all monies belonging to the Church Organization and shall be solely responsible for such monies or securities of the Organization. He shall deposit in a regular business bank all the monies and checks received for the organization. He must be one of the officers who shall sign checks or drafts of the organization. He shall exercise all duties incident to the office of Treasurer.
