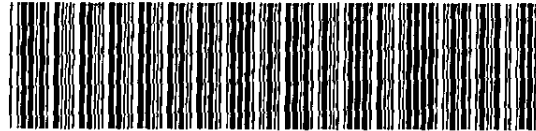

ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

Community Faith Outreach Ministries, Incorporated-a not-for-profit organization.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

To raise the economic, educational, and social levels of underprivileged minorities residing in Palm Beach and Broward Counties; To foster and promote community-wide interest and concern for the problems of the Bi-County communities that will reduce group discrimination and social stigmas through various collaborations.

1. To furnish credit counseling, small business development training, and how to establish a working Board or Advisory Council.
2. To partner with the Faith-Base communities through pray networks, joint food & clothing distribution, community activities, other events, health education, and housing placement services.
3. To establish a Multi-Resource Center that provides therapeutic counseling, groups, career assessments, and other testing.
4. To conduct conferences, open forums, activities, and other collaborative efforts that foster sound and constructive relationships between the identified communities leading to the development of other mentoring partnerships.

5. To promote informed decision-making about job selection, housing rehabilitation, financial investments, and other ways to improve one's welfare and economic conditions.
6. To obtain information and conduct research studies to analyze the problems/possible solutions of the Bi-County communities and prepare/publish reports that may be of use in furthering the expansion business enterprises and other collaborations.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

Individuals in the communities are identified who are sensitive to the mission of Community Faith with intact values, morals, commitment, and resources that will perpetuate the organization's purpose. The initial Executive Board may interview potential candidates to serve on the Board Directors for a two-year term. Upon mutual acceptance, the individual maybe elected for another four-year term.
