**ARTICLES OF INCORPORATION
OF
VILLAGE OUTREACH MINISTRIES, INC.
A NON-PROFIT CORPORATION**

ARTICLE I: CORPORATE NAME

The name of this corporation is Village Outreach Ministries, Inc.

ARTICLE II: PRINCIPAL OFFICE

2505 NW 13th Court , #3
Fort Lauderdale, Fl 33311

ARTICLE III: TERM OF EXISTENCE

The period of duration of this corporation is perpetual.

ARTICLE IV: NOT FOR PROFIT CORPORATION

This corporation is not organized for profit or organized in an activity ordinarily carried on for profit, and no part of its net earnings shall inure to the benefit of any private shareholder or individual. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by a Corporation exempt from Federal Income Tax under Sections 501(c) of the Internal Revenue Code (or the corresponding provision of any future United States Internal Revenue Law).

ARTICLE V: PURPOSE

The purpose of Village Outreach Ministries is to prevent Drug Abuse, Violence, Teen Pregnancy, School Drop Out, & Delinquency. This program will allow us to nurture young souls with influence of spiritual guidance and to increase a healthy family environment with clinical supervision.

ARTICLE VI: MEMBERSHIP

The membership of Village Outreach Ministries shall consist of the following:

1. Voting Members, as per by-laws.
2. Advisory Members, as per by-laws.

ARTICLE VII MEETINGS

1. Annual Meetings

The Board of Directors shall meet annually. The exact time and place of such meetings shall be determined by the Board of Directors.

2. Quarterly Meeting

The Board of Directors shall meet quarterly. The exact time and place of such meetings shall be determined by the Board of Directors.

3. Special Sessions

Special Sessions may be called upon by agreement of the Board of Directors, as the occasion demands.

ARTICLE IX: BOARD OF DIRECTORS

**The four (4) Incorporators shall be the Board of Directors.
Their names and addresses are as follows.**

Minister Lynette R.J.Brown President

Minister Jeffery G. Gibbons Vice President

David Smith – Treasurer

Annie L. Hamilton – Executive Secretary

ARTICLE X

Future vacancies on the Board of Directors shall be filled accordingly:

- a. The President and Vice President shall nominate director candidates and
- b. A quorum of the Board Of Directors shall grant final approval. If the number of Directors then in office is less than a quorum, a vacancy on the board may be filled by approval of a majority of the directors then in office or by a sole remaining director. A person elected fill a vacancy on the Board shall hold office until next election of the Board of Directors or until his or her death, resignation or removal from office.

ARTICLE XI: INCORPORATORS

ARTICLE XII: INITIAL REGISTERED AGENT AND OFFICE

ARTICLE X111

These articles may be amended only in the manner prescribed by statute.

ARTICLE XIV: ANY ADDITIONAL PROVISIONS FOR THE OPERATION OF THE CORPORTION

Upon the dissolution of this corporation, its assets remaining after payment, or Provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code, and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements, any political campaign on behalf of, or in opposition, to any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or to be distributable to its members, its members, directors, officers or any private persons except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and make payments and distributions in furtherance of the purposes set forth in these Articles.

Notwithstanding any other provision of these articles, the corporation shall not


carry on any other activities not permitted to be carried on:

- (a.) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or
- (b) by a corporation, in contribution, to which are deductible under section 170(c) (2) of the Internal Revenue Code of 1954 (or corresponding provision of any future United States Internal Revenue Law).

ARTICLE XV: EFFECTIVE DATE:



Shall become effective February 1, 2005


