Pursuant to the provisions of § 617.1006, Fla.Stat., the undersigned Florida nonprofit corporation adopts the following Articles of Amendment to its Articles of Incorporation. The purpose of this Amendment is to change the corporate name of the Association and to amend Section 3.1 to reflect the change in the community's name:

- 1. **NEW CORPORATE NAME:** The new corporate name shall be:
 - Carpentras at the Villages of Avignon Homeowners Association, Inc.

- 2. **Additional Amendments adopted:**

Section 3.1 is hereby amended as follows:

3.1 The purpose for which the Association is formed is to provide an entity for the maintenance, preservation, management, control, administration, and operation of property in Manatee County, Florida, subject to the Declaration of Protective Covenants for Oak View, recorded ~~or to be recorded~~ in Official Record Book 2029, Pages 4752 et seq. of the Public Records of Manatee County, Florida, ~~as amended or to be amended~~ to reflect a change in the community's name from "Oak View" to "Carpentras at the Villages of Avignon", or as it otherwise ~~as it~~ may be lawfully amended and/or supplemented from time to time (the "Declaration"), and its exhibits thereto, as they may be lawfully amended and/or supplemented from time to time (collectively, the "Community Documents").

- 3. The date of the adoption of the amendment was: December 8, 2006.
