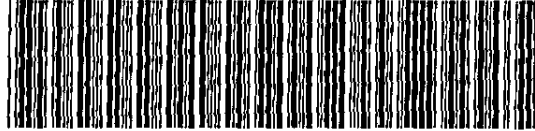

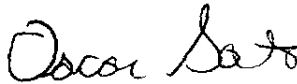

The undersigned, by these Articles associate themselves for the purpose of forming a corporation not for profit under Chapter 617, Florida Statutes, and certify as follows:

ARTICLE I. NAME

The name of the corporation shall be LAS ROSAS CONDOMINIUM ASSOCIATION, INC.

ARTICLE II. DURATION AND COMMENCEMENT OF EXISTENCE

The corporation is to have perpetual existence, commencing at the filing of these articles with the Department of State.

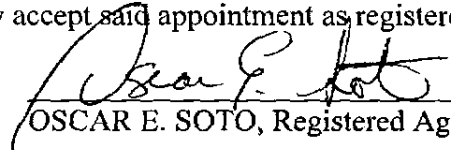
ARTICLE III. PURPOSE

ARTICLE VI. PRINCIPAL OFFICE

The principal office of the corporation shall be located at 3051 Riverside Drive, Coral Springs, Florida 33071.

ARTICLE VII. POWERS AND MANAGEMENT OF THE CORPORATION BY THE BOARD OF DIRECTORS

ARTICLE IX. INITIAL BOARD OF DIRECTORS

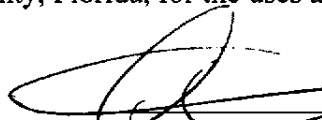
This corporation shall have three directors initially, The number of directors may be increased or decreased from time to time by the by-laws. The names and addresses of the initial directors of this corporation are:
