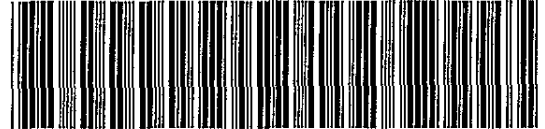

Articles of Incorporation

The undersigned, acting as incorporators of a corporation not for profit pursuant to Chapter 617, Florida Statutes, adopt the following articles of incorporation for such corporation.

Article I

The name of the Corporation is Iglesia Del Nazareno Naples Inc and the initial principal address of the Corporation is: 6455 Hidden Oaks Lane, Naples, FL, 34119.

Article II

The period of duration of this Corporation is perpetual, unless dissolved according to law. Corporate existence shall commence upon the first day of March, 2005.

Article III

The purpose for which the Corporation is organized are as follows:

1. To establish and maintain a local congregation for the purpose of Christian ministry.
2. To preach the Gospel of Jesus Christ, promote holiness and the worship of God among its members and attendants, and the practice of Christian virtues as admonished by the Holy Scriptures.
3. To call and discharge ordained, licensed and commissioned ministers of the Gospel, and others, to conduct and carry on divine services at a place of worship, and elsewhere, and to collect and disburse any and all necessary funds for the maintenance of said Corporation and ecclesiastical body being the local congregation known as the Iglesia Del Nazareno Naples Inc.
4. To provide appropriate religious education and training for its members and those attending its church school and other educational meetings and classes.
5. To acquire property whether real, personal or mixed, by purchase, gift, legacy, bequest or in any manner and to borrow money, issue bonds or notes, and all other documents necessary or appropriate in carrying out the objects and purposes set forth in this Article III.
6. To do all and everything necessary, suitable or proper for the accomplishment of any of the purposes or the attainment of any one or more of the purposes herein stated, or incidental to the powers named, or which shall at any time appear conducive or expedient for the promotion of its welfare, and the accomplishment of the purposes herein stated.

Article IV

The terms of admission to membership in this Corporation shall consist of membership in good standing in the ecclesiastical body known as the Iglesia Del Nazareno Naples Inc and each member in good standing in such ecclesiastical body shall by virtue thereof be a member of this Corporation. Membership shall be conditioned upon the acknowledgment and acceptance of the beliefs and tenants as published in the **Manual** of the Church of the Nazarene.

Article V

The street address and city of the initial registered office of the Corporation: 6455 Hidden Oaks Lane, Naples, FL 34119; and the name of the registered agent at such address is Julio A. Palacios, Pastor and President.

Article VI

The affairs of the Corporation shall be managed by a Board of Trustees, which shall consist of not less than three (3) and not more than nine (9) members of the Corporation in good standing. The number, tenure of office, manner of election and filling of vacancies shall be as provided in the By-Laws of the Corporation.

Article VII

This Corporation is organized under a non-stock basis.

Article VIII

This Corporation is organized under Section 501 © (3) of the Internal Revenue Code of 1954 as a subordinate unit under an original group exemption letter issue to the General Board of the Church of the Nazarene at its headquarters in Kansas City, Missouri on July 12, 1963. In the event of the dissolution of the Iglesia Del Nazareno Naples Inc the residual assets of the organization will be distributed as voted upon by a majority of the members present in a duly called meeting for the purpose of dissolution.

Article IX

The officers of the Corporation are the incorporators. The officers of the Corporation shall consist of a President, a Secretary and Treasurer. The Secretary and Treasurer may be the same person. The manner of election, tenure of office and filling of vacancies shall be as provided in the By-Laws of the Corporation.

Article X

The Corporation shall provide By-Laws for its government not inconsistent with these Articles of Incorporation, the laws of the State of Florida and the United States of America.

Article XI

These Articles of Incorporation may be amended by a vote of two-thirds (2/3rds) of the members present at an annual meeting or special meeting called for such purpose provided that notice of the proposed amendment shall be given to the membership in accordance with the provisions of the By-Laws and in accordance with any requirements of the Church of the Nazarene as they are from time to time set forth in the official **Manual** of the Church published by the authority of the General Assembly of the Church of the Nazarene.

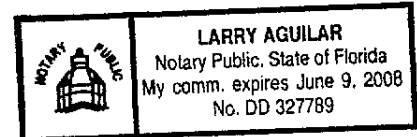
